**FY2011 DESIGNATED HIGH PRIORITY ITEM - PRIORITY TOPIC**

**SUBJECT TITLE:** Official date of the Municipal Elections

**EXPLANATION:** The Commission expressed a desire to hold the 2012 Municipal Elections the same day as the Presidential Preference Primary Election for the purpose of electing one Commissioner from District 1, Seat 1; District 2, Seat 2; and Mayor at Large. The Elections Committee has selected January 31, 2012 as the date of the Presidential Preference Primary. Therefore, qualifying for the Municipal Elections begins at noon November 8<sup>th</sup> and ends at noon on November 22<sup>nd</sup>.

An ordinance moving the Municipal Elections from March 2012 to January 2012 will be placed on the October 25, 2012 Commission meeting agenda for 1<sup>st</sup> reading. We recommend having the 2<sup>nd</sup> reading of the ordinance on November 8, 2012 rather than wait until the meeting of November 29<sup>th</sup>.

Note: We were required by law to place a public notice thirty days before the qualifying date, so we have placed that notice in the Sun-Sentinel, El-Sentinel and is noticed on our web site as well as on Channel 78.

THE TOWN OF LAUDERDALE BY-TH-SEA WILL HOLD ITS MUNICIPAL ELECTION ON TUESDAY, JANUARY 31, 2012, FOR THE PURPOSE OF ELECTING:

ONE COMMISSIONER FROM DISTRICT 1, SEAT 1; ONE COMMISSIONER FROM DISTRICT 2, SEAT 2; AND MAYOR AT LARGE

- ALL CANDIDATES MUST BE REGISTERED ELECTORS IN BROWARD COUNTY AND RESIDE IN THE DISTRICT WITHIN THE CORPORATE LIMITS FOR WHICH THEY FILE, WITH THE EXCEPTION OF THE MAYORAL POSITION, WHICH CANDIDATE MAY RESIDE IN ANY DISTRICT WITHIN THE CORPORATE LIMITS OF THE TOWN OF LAUDERDALE-BY-THE-SEA.
- ALL CANDIDATES MUST OPEN A CAMPAIGN CHECKING ACCOUNT PRIOR TO QUALIFYING.
- ALL CANDIDATES MUST QUALIFY WITH THE TOWN CLERK, TOWN HALL, 4501 OCEAN DRIVE, LAUDERDALE BY-THE-SEA, FL. 33308

THE QUALIFYING PERIOD TO RUN FOR OFFICE BEGINS AT NOON, NOVEMBER 8, 2011 AND ENDS AT NOON, NOVEMBER 22, 2011.
