FY2011 DESIGNATED HIGH PRIORITY ITEM - PRIORITY TOPIC

SUBJECT TITLE: Ordinance 2011-19 – Renaming Municipal Park to Friedt Family Park

EXPLANATION: The Commission expressed their desire to recognize the Friedt Family for their contributions to the municipal park, by renaming the park "Friedt Family Park", and to also recognize the additional contributions of other Town benefactors as was deemed in Ordinance 2005-04:

- the soccer field "Firefighters' Field"
- the tennis courts "Sylvia Neely Tennis Courts" in honor of Sylvia Neely
- the bocce courts "Spicola Courts" in honor of Michael S. Spicola

The cost of modifying the existing park sign to say "Friedt Family Park" is approximately \$1,200 (We are seeking additional bids). We have not yet got cost estimates for the other three signs, though they will be much less costly.

RECOMMENDATION: Adopt Ordinance 2011-19 on first reading.

ORDINANCE 2011-19

AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF LAUDERDALE-BY-THE-SEA, FLORIDA, AMENDING ORDINANCE NO. 2005-04 TO RENAME "MUNICIPAL PARK" TO "FRIEDT FAMILY PARK" IN HONOR OF THE FRIEDT FAMILY; PROVIDING DIRECTION TO THE ADMINISTRATION; PROVIDING FOR CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

11 **WHEREAS**, Ordinance No. 81 dedicated and named the municipal park as "Friedt Park
12 and Recreation Center" in recognition of Glenn H. Friedt and Lucy Friedt, pioneer developers and
13 respected civic leaders of the Town of Lauderdale-By-The-Sea (the "Town"); and

14 **WHEREAS**, Ordinance No. 2005-04 rescinded Ordinance 81, changed the name of "Friedt
15 Park and Recreation Center" to "Municipal Park" and additionally designated the playground area
16 as "Friedt Family Playground," the soccer field as "Firefighters' Field," the tennis courts as "Sylvia
17 Neely Tennis Courts," and the bocce courts as "Spicola Courts;" and

18 **WHEREAS**, the Town Commission finds that is beneficial and proper to recognize the
19 contributions to the development of the Town by Glenn H. Friedt, Lucy Friedt and the Friedt family
20 through their generosity and commitment to improving the quality of life in the Town for the benefit
21 of the residents, property owners and guests; and

22 **WHEREAS**, the Town Commission wishes to recognize the Friedt family contributions by
23 renaming "Municipal Park" as "Friedt Family Park," and to also continue to recognize the
24 additional contributions of other Town benefactors currently recognized in the designation of
25 specific areas and facilities in the park.

26 **NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF**
27 **THE TOWN OF LAUDERDALE-BY-THE-SEA, FLORIDA THAT:**

28 **SECTION 1. Recitals.** The foregoing "Whereas" clauses are hereby ratified and

1 confirmed as true and correct and incorporated herein by this reference.

2 **SECTION 2. Ordinance Amendment.** Ordinance 2005-04, adopted on January 11, 2005,
3 is hereby amended as follows:

4 Section 2. Ordinance 81 of the Town is rescinded and the following adopted
5 in its place:

6 Friedt Park and Recreation Center is hereby renamed “Friedt Family Park”
7 ~~“Municipal Park”~~; ~~the playground area is hereby named “Friedt Family~~
8 ~~Playground”~~ in honor of the ~~Glenn H. Friedt and Lucy Friedt~~; the soccer
9 field is named “Firefighters’ Field”; the tennis courts are named “Sylvia
10 Neely Tennis Courts” in honor of Sylvia Neely; and the bocce courts are
11 named “Spicola Courts” in honor of Michael S. Spicola.

12
13 **SECTION 3. Ordinance Status.** All portions of Ordinance 2005-04, except as amended
14 herein, shall remain in full force and effect.

15 **SECTION 4. Direction to Administration.** The Town Administration is directed to
16 install appropriate signage for the park as described herein.

17 **SECTION 5. Conflicts.** All Ordinances or parts of Ordinances, Resolutions or parts of
18 Resolutions in conflict herewith are hereby repealed to the extent of such conflict.

19 **SECTION 6. Severability.** If any clause, section or other part of this Ordinance shall be
20 held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional
21 or invalid part shall be considered as eliminated and in no way affecting the validity of the other
22 provisions of this Ordinance.

23 **SECTION 7. Effective Date.** This Ordinance shall take effect immediately upon its
