**RESOLUTION 2011-04**

**A RESOLUTION OF THE TOWN COMMISSION OF THE  
TOWN OF LAUDERDALE-BY-THE-SEA, FLORIDA,  
SETTING THE MAXIMUM NUMBER OF PARKING  
EXEMPTION SPACES AVAILABLE FOR THE PARKING  
EXEMPTION PROGRAM; PROVIDING AN EFFECTIVE  
DATE**

**WHEREAS**, Ordinance 2011-01 created the Parking Exemption Program to provide parking relief to new and expanding restaurant uses within the Town; and

**WHEREAS**, the Town Commission designated two separate districts for the implementation of the Parking Exemption Program, the Ocean Front Center and the Commercial Business District; and

**WHEREAS**, Ordinance 2011-01 requires that the Town Commission establish the maximum number of parking exemption spaces available in each district by resolution; and

**WHEREAS**, the Town Commission desires to establish a maximum number of parking spaces available in each district for the Parking Exemption Program.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAUDERDALE-BY-THE-SEA, FLORIDA:**

**SECTION 1.** Pursuant to Section 30-318(j)(3)(i) of the Lauderdale-By-The-Sea Code of Ordinances, as created by Ordinance 2011-01, the maximum numbers of parking exemption spaces are hereby established as follows:

Oceanfront Center District:	120 spaces
Commercial Business District:	105 spaces

**SECTION 2.** This resolution shall become effective upon passage and adoption.
