FY2011 DESIGNATED HIGH PRIORITY ITEM - PRIORITY TOPIC

SUBJECT TITLE: Special Event - Four (4) Pet Clinics at the Walgreens Store on Four Dates

EXPLANATION: The Pet Stop and Walgreens have submitted the attached special event application (**Exhibit 1**) to hold a pet clinic on the Walgreens' property on Saturday January 21st and March 24th and on Sunday February 19th and April 22nd.

The event is approximately 1 ½ hours in length. They estimate they will have up to 10 participants.

This event was held once prior to the applicants knowing they needed a special event permit. There were no problems with the one event.

RECOMMENDATION: We recommend approval with the following conditions.

1. Applicant shall comply with all aspects of their application.
2. The Town Manager may suspend permission for this event or the onsite Town representative may terminate an event due to the applicant not complying with the terms and conditions of the Town's event permit or for health or safety issues, such as crowds that exceed the capacity of the event site.
3. In the event that insurance certificates, licenses and other material requirements are not provided by the required dates, the approval for this event shall expire unless the Town Manager finds there are extenuating circumstances that the event sponsors have cured or can immediately cure without compromising the health, welfare and safety of the citizens of the Town of Lauderdale-By-The-Sea or those attending the event and by paying for the additional administration costs, if any, of the Town.




