SUBJECT TITLE: Code Compliance Status Report

EXPLANATION: At your meeting on November 29, 2011, the Commission approved a sole source contract with Calvin, Giordano and Associates Inc. to provide code compliance services for the calendar year 2012.

Almost nine months has past and we wanted to provide a status report to the Commission of the activities to date. Calvin-Giordano has provided the attached report (Exhibit 1), which highlights the 454 compliance cases they have managed, the 1,415 inspections conducted and a list of the other types of activities (reprinted in Table 1) that they are involved in on our behalf. In addition, a list of the 90 open cases is attached (**Exhibit 2**) as well as a list of all cases since January 2012 (**Exhibit 3**).

Staff feels that contracting out code services has been very successful. There is always an initial learning curve with a new contractor, but Calvin Giordano got up to speed very quickly. The productivity and effectiveness of code enforcement has improved, we think significantly, over when we handled it in-house. We attribute this to several factors. One, Town staff was quite lenient in extending compliance dates when property owners requested extensions, sometimes giving multiple extensions. That extreme cooperativeness meant that the violations continued for long periods of time. While the Calvin Giordano team will extend deadlines, they look for demonstrable effort on the part of the property owner to correct the problem, and there are fewer extensions. Second, there was often a long time lapse between when Town staff issued the notice of violation (NOV) and then the case was scheduled for a hearing before the Code Magistrate. Calvin Giordano has eliminated the second step and the delays by including on the NOV the date the case will be heard before the Code Magistrate if the violation is not corrected by a defined date. That has caused property owners to take the NOV more seriously and we are getting compliance more quickly. Third, in the past we often pulled the Town Code Inspector off code work to assist with other pressing matters and the Senior Code Inspector had duties in addition to code enforcement. With the Calvin Giordano contract we get more hours devoted to code enforcement.
