**SUBJECT TITLE: Ocean Conservancy's International Coastal Cleanup on September 25, 2010**

**EXPLANATION:** Broward County coordinates the annual Ocean Conservancy's International Coastal Cleanup. This year the event is on September 25 and the Town has been asked to again participate by providing parking for the volunteers and a dumpster. Municipal Services has coordinated our activities in the past and is prepared to do so again for the 2010 event.

In 2008, Broward County advises that 87 volunteers participated in the Lauderdale-By-The-Sea cleanup and over 2,385 volunteers participated county wide.

If approved, we will provide parking in the Bougainvillea Parking Lot. This will not have a cost to the Town as this is a morning event and no paid parking should be displaced. Choice provides the dumpster at no charge to the Town.
