

Below is contact info for Yvette Lopez, the person I mentioned to you who has been helpful with regard to CDBG interpretation of provisions and the senior center funding agreement. Also, the funding agreement is attached per your request. Commissioner Sasser indicated staff should confirm with the County that the change would be acceptable.
