Code Enforcement Activities

The Code enforcement staff opened 96 cases, closed 50 cases and completed 248 total inspections. No additional hotel inspections were made as staff was focused on following up on those inspections completed in February. Fifteen cases were heard by the Special Magistrate. At the February Special Magistrate meeting, the Special Magistrate certified a code fine reduction on Aquazul from \$43,050 to \$10,000. The violation was for having lighting directly illuminating the beach during sea turtle season. This month, staff collected Aquazul's mitigated fine. These funds are not listed in the detailed code summary (**Exhibit 1**) because the case was opened prior to the Calvin Giordano and Associates contract. **Exhibit 2** includes a detailed summary of those cases opened and closed this month.
