**On April 4, 2013, I received an invitation from Brad Kaine, Director of Governmental Affairs, to tour the Sun Bergeron recycling plant in Pompano Beach, FL. I accepted the invitation and visited the facility on April 10. Although Brad Kaine is not a registered lobbyist, Sun Bergeron is bidding on the solid waste contract with Lauderdale-By-The-Sea and could potentially become a town contractor. Accordingly, I am disclosing this contact.**

**My tour of the recycling plant was conducted by Brad Kaine and Dale Henderson, Facility Manager. They showed me the different types of equipment which is used at the plant to separate different types of solid waste, such as construction debris, metals, plastic, rock and yard waste. They explained how these materials are reprocessed for new uses. We talked about issues such as the cost of their operations, environmental safety, and the future of waste disposal and recycling in Broward County. It was a very informative meeting and I feel I learned a lot about their technology and operations. Sun Bergeron also provided me with a briefing book on the current state of recycling in Broward County which I picked up at town hall on April 12, 2013.**
