Pursuant to the Town's Code of Ordinances ("Town Code") Section 30-127 "Variance Procedures and Requirements," the Applicant requests variances from, (1) Town Code Section 30-313(r) to permit the installation of mechanical equipment on the rooftop where the Town Code provides that mechanical equipment may not be installed in excess of six (6) feet above grade; and (2) Town Code Section 30-313(t) to permit the installation of a permanent generator on the rooftop of a duplex structure, where the Town Code provides that permanent generators are not allowed to be installed on the roof of a building in a duplex zoning district.
