**Request:** Pursuant to Chapter 30 “Unified Land Development Regulations” of the Town’s Code of Ordinances (“Town Code”), the Applicant has requested a Conditional Use Approval (2022-CU-01) to permit a Mixed-Use Development in the B-1 Zoning District, Flex Unit Allocation (2022-FXU-01) to create two (2) second-floor dwelling units, and Site Plan Modification (2022-L2-SPM-02) for the property located at 233 E Commercial Boulevard.

AFFECTED PERSONS WILL BE ALLOWED TO PRESENT EVIDENCE AT THE PUBLIC HEARING(S), BRING FORTH WITNESSES, AND CROSS EXAMINE WITNESSES PROVIDED NOTIFICATION AND FILING OF SUCH INFORMATION IS MADE WITH THE TOWN CLERK PRIOR TO THE ABOVE PUBLIC HEARING(S).

IF ANY PERSON DECIDES TO APPEAL ANY DECISION MADE WITH RESPECT TO ANY MATTER CONSIDERED AT THE PUBLIC HEARING(S), HE/SHE WILL NEED A RECORD OF THE PROCEEDINGS AND FOR SUCH PURPOSES MAY NEED TO ENSURE THAT A VERBATIM RECORDING OF THE PROCEEDINGS IS MADE, WHICH RECORDS INCLUDE THE TESTIMONY AND EVIDENCE UPON WHICH THE APPEAL IS TO BE BASED.
